Summary :

This is a an Agreement to waive, indemnify and release St. Paul's School (the "School") and others regarding activities and risks associated with participation in the Ropes Course at the School (the "Agreement"). All Parents or Guardians identified on the enrollment contract for the Student identified above (the "Student") shall sign this Agreement on behalf of the Student regardless of the age of the Student. This Agreement will be valid and binding on the signature of one Parent or Guardian. By signing, the Parents or Guardians acknowledge that the Parents or Guardians have read and understood the Agreement, have had the opportunity to obtain legal counsel regarding the Agreement and are legally bound by the Agreement. As such, the Parents or Guardians are releasing all claims on behalf of the Student and the Parents or Guardians against the School and others associated with participation in the Ropes Course at the School. Students who are 18 or older also must sign this Agreement and, by doing so, acknowledge that the Student has read and understands the Agreement, has had the opportunity to obtain legal counsel regarding the Agreement and is legally bound by the Agreement. The Parents or Guardians and the Student state they understand the activities and risks of the Ropes Course and assume all known and unknown risks. The details of the Agreement are provided below.

I, the undersigned, _____, request that the Student identified above be permitted to participate in activities associated with the Ropes Course located on the premises of St. Paul's School (the "Activity").

In consideration for the Student's participation in the Activity, I agree to the following:

The Student's involvement and/or participation in the Activity is voluntary and the Student is acting under his or her own free will.

I consent to the Student's participation in the Activity and acknowledge that the nature of the Activity may require mental judgment and a high degree of physical fitness, agility, and dexterity that requires physical fitness, strength, and stamina. The Student is in good health and has no medical ailments, physical limitations, mental disturbances, emotional instability or other conditions that would prevent participation in the Activity.

I understand that the Student's participation may involve risks, including, but not limited to, danger, serious injury, bodily harm, emotional stress, or death, including losses caused by the Student's or others' actions, inactions or negligence, and/or the condition of the facilities, equipment, or location where the event or Activity occurs. There also is the potential for risks or dangers that may not be obvious or reasonably foreseeable at this time. Knowing and understanding the risks associated with the Activity, I voluntarily and willingly assume responsibility for all risks and dangers associated with the Activity. I also agree that I am financially responsible for any losses or liabilities resulting from the Student's actions or inactions, and will indemnify St. Paul's School and its officers, directors, employees and agents, for any loss, damage or other liability caused by the Student at this Activity. St. Paul's undertakes no legal or financial responsibility for the Student's safety or well-being when the Student is participating in the Activity.

I waive all claims or causes of action against St. Paul's School and its officers, directors, employees and agents, arising out of the Student's participation in the Activity and hereby agree to release, indemnify, hold harmless, and

discharge St. Paul's School and its officers, directors, employees and agents from all liability in connection with the Activity including, but not limited to, any loss, damage or other liability associated with this Activity.

I have read this Agreement and the Summary above, which is incorporated into the Agreement, and understand the terms used and their legal significance. This waiver, indemnity, and release is freely and voluntarily given with the understanding that right to legal recourse against St. Paul's School and its officers, directors, employees and agents is knowingly waived, any and all claims released and indemnification established for them in return for allowing the Student to participate in the Activity. My signature on this document is intended to bind not only myself, but also my successors, heirs, representatives, administrators, and assigns, and the Student on the Activity. This Agreement is binding on me regardless of whether the Student is over 18 years old.
